## Introduction

- Last year, with the imminent passage of the Inflation Reduction Act, which contained language directing the IRS to study a direct file system, MITRE conducted two surveys to gather data to evaluate taxpayer filing choices.
- The purpose of the surveys were to evaluate how certain factors of hypothetical tax filing systems affect taxpayers' interest in using those systems. Gauging that interest may help determine which features (or lack of features) may either deter taxpayers or make direct filing more appealing to taxpayers if the IRS were to build such a system.
- The hypothetical tax filing systems presented in the surveys were IRS Direct File, an IRS-run tax software program that would give taxpayers the same functionality as commercial tax software packages, and IRS Return-Free filing, in which taxpayers with simple returns (W-2 income only, no credits, itemizations or deductions others than the standard deduction) would not have to file a tax return, and the IRS would notify them of how much their refund would be, or how much they owed, with the opportunity to correct the return.
- The first survey assumed simple returns (as defined in the previous bullet) and gave the respondents the choice of their current software program (all respondents were current self-preparing commercial tax software users), IRS Direct File or IRS Return-free file. All three programs were free.



# Introduction (cont.)

- The second survey assumed more complex returns, with additional forms, schedules, credits or itemizations, and gave the respondents the choice of their current software or IRS Direct File.
- While the surveys determined what percentage of taxpayers would use each of the hypothetical methods presented to them in each scenario, it was not intended to determine what the actual uptake of usage would be should those hypothetical filing systems become a reality.
- These independent surveys were conducted in keeping with MITRE's role as the operator of Treasury/IRS's Federally Funded Research and Development Center (FFRDC), and the requirement by the Sponsoring Agreement with Treasury/IRS to conduct independent research related to anticipated future needs of its Sponsor (Treasury/IRS).
- MITRE engaged YouGov, an international research data and analytics group, to conduct the surveys.

# Methodology

## Research Design

Respondents were invited to participate in one of two survey versions, Simple Tax Return or Complex Tax Return.

- Simple Tax Return respondents were asked to imagine themselves getting ready to prepare their taxes requiring only their job-related income and standard deduction.
- Respondents were then presented with four separate scenarios in which they could select from three tax preparation options: their current software, IRS Direct File, or IRS Return-Free file. All software options held constant with no cost.
- Complex Tax Return respondents were asked to imagine themselves getting ready to prepare their taxes requiring their income from wages or interest along with additional forms or schedules, such as business income, tax credits or itemized deductions.
- Respondents were then presented with four separate scenarios in which they could select from two tax preparation software options – their current software for a fee of \$80 or IRS Direct File for free.




## Simple Tax Return Demographics



Most participants chose to stay with their current software, keeping with what they know. For those willing to try IRS Software, more interest shown in having the IRS do all the work, with little interest in IRS Direct File.

#### Same Function, Same Cost, No State Return

When state return is excluded, using IRS software is less than ideal. Most want to endure going through tax preparation only once and file both federal and state together using their current software. Filers that live in states that do not require tax returns, are slightly more likely to select IRS software platform than those who live in states which require state tax returns.

Less work for the preparer starts to sweeten the deal; perceptions that the IRS already has the information sways filers to use IRS Software, although more lean towards IRS Return Free File than IRS Direct File. Those opting to stay with their current software simply do not want the IRS to be involved with their tax preparation.

Although some prefer having the IRS complete their taxes since the IRS already has the information, most prefer to stay with their current software in order to file federal and state taxes together. Among filers that live in states without a tax return, most continued to select their current software, although more were driven to use the IRS software than filers who file state returns.

# **Simple Tax Return**

- IRS Direct File is the least favored tax preparation software, indicating filers want familiarity by staying with current software, or IRS Return-Free offering effortless filing.
- Lack of trust in the government is a key reason for those selecting current software, regardless of what the IRS can offer.
- Established filers with years of tax history will be hard pressed to leave their current software since it contains historical information.
- Best option to sway current software filers to use IRS Direct is to include state returns.

I like turbo tax and am not interested in changing, even if it costs money to use turbo tax (Current Software)

Security and length of time (IRS Direct File)

Familiarity with my software. (Current Software)

More expedited this way since I already have an account and software with this rather than the need to create an account for the IRS stuff *(Current Software)* 

I would think filing directly would get me my refund quicker. (IRS Direct File)

If the govt. is requiring me to file they should offer a free service (*IRS Return Free File*)

It should be free and effortless to file taxes (IRS Return-Free file)

Commercial software is made intentionally confusing to encourage you to by a higher package (*IRS Direct File*)





Complex filers are looking to save money and feel the IRS Direct File is the best option, even if they have to file state taxes separately. Among those who live in states that do not require tax returns, 70% of tax filers chose to use IRS Direct File, significantly more than those who live in states that require tax returns (55%).





Even when excluding state returns, Complex filers prefer to use a free federal filing option over giving information to a third party. When filing a state return is not required, 69% of tax filers in states that don't require tax returns selected the free IRS Direct File software.



# **Complex Tax Return**

- Having access to free IRS software is in line with some views that one shouldn't have to pay for mandatory tax filing.
- Lack of trust in the IRS is prevalent for those filing Complex Returns. Some would rather spend money on commercial software than use IRS software.
- Access to historical tax information has the potential to be a valuable feature for IRS Direct.
- Creating a user interface that is intuitive for all ages could sway current software users to switch to IRS software.

*"I think it would take way too long and doing it all myself with TurboTax takes me no time at all." (Current Software)* 

"The tax software I use has my history of previous tax reports for 5+ years." (Current Software)

"Easier to do tax prep under program with IRS." (IRS Direct File)

"I'm going to have to pay for the State, why not do both at once." (Current Software)

"Don't want my money going to a private tax preparation company." (IRS Direct File)

"State taxes preparation are going to cost me money, so the IRS being free no longer offers any value." (Current Software)

"Filing taxes should be done automatically for free by the IRS." (IRS Direct File)

"You can't force people to Do something by law AND make them pay for it." (IRS Direct)

#### "The IRS cannot be trusted". (Current Software)

"... allows the user to try scenarios to see how taxes are affected. I do not trust that the IRS would not use that data against me even if everything I looked at was 100% legal". (Current Software)

"I do not believe the customer service of the IRS would be as good as that of the current company." (Current Software)

"The government is untrustworthy." (Current Software)

"The IRS already has income information and should be able to confirm there were no input errors before submitting the form." (IRS Direct)





## Tax Filers Are Motivated by Convenience and Saving Money

Simple Tax Return filers opt to stick with their current software when cost is the same between all options. Complex Tax Return filers lead with their pocketbook and opt for free IRS Direct File software. When the state return is excluded, less interest is shown in using free IRS software for both Simple and Complex filers.

## **Summary of Findings**

Tax filers want fast, easy and free. However, they will exchange cost over convenience showing willingness to pay for commercial service when it comes to filing federal and state returns at the same time.




- People are looking for the most convenient and efficient way to prepare their taxes
- For Simple tax returns, many opt to stay with current software thinking 'if it's not broke, why fix it'
- Younger population shows higher interest in *IRS Return Free File* since there is little effort required on their part



- For Complex tax returns, majority are open to using free IRS Direct File software instead of paying for commercial software
  - Although some are willing to pay for commercial software if it means better data security, audit protection, and solid customer service



- Older generations are sticking with what they know and trust and opt for their *Current Software*
- Lack of trust in the IRS and Government plays a large role when selecting software
- Some feel advanced security technology goes too far, while others think the IRS will not have enough security



- IRS will need to match or surpass available software options, such as safeguards against tax audits and superior customer service
- Including both federal and state tax preparation will move more people towards using IRS software
- Can build trust in the IRS by marketing advanced data security and enough staff
